### Course Description and Objectives

In this course, students learn how to summarize data, analyze it, and make appropriate decisions based on it. The sequence of courses STA 2023-3024 provides students with a firm foundation in the basics of applied statistical methods. The prerequisite for this course is STA 2023, which covered chapters 1-10 in the textbook (data collection, graphical and numerical summaries, probability, and an introduction to statistical inference). Concepts from STA 2023 will be reviewed as needed.

The course focuses on the following four topics:

1. Analysis of Variance to compare three or more population means.
2. Simple Linear Regression and Multiple Regression to predict a quantitative response.
3. Analysis of Two-Way Tables to study the relationship between two categorical variables.
4. Nonparametric Statistics that do not require a Normal distribution of the response variables.

## Required Course Materials

**Lecture Notes:** These are needed to follow along with the lectures. You can print them from the Lecture Notes link on the course home page. Alternatively, you can use them electronically if your device is able to write on a pdf.

**Scientific Calculator:** You will need a scientific calculator with some basic statistical functions such as mean and standard deviation. The calculator will be needed for in class exams.

**Textbook:** Statistics: The Art and Science of Learning from Data by Agresti, Franklin, Klingenberg, 5th Edition. Purchase this as an etext through UF All Access for around \$70 for the semester. As well as the etext you will also get access to the homework problems and StatCrunch statistical software. See the instructions on this [flyer](#) for opting in to UF All Access.

**Reliable Computer:** This includes having access to an Internet connection. You will need this to view Canvas, complete the homework, and turn in the computer assignments.

## Course Assignments

In this class, your overall grade will be made up of homework, computer assignments and exams.

**Homework:** There will be approximately eight homework assignments. These will be online through My Lab and Mastering. You will need to opt in to UF All Access to be able to complete them. You will get three attempts for each homework, with the highest score counting. The tentative due dates are given on the course schedule.

**Computer Assignments:** There will be four computer assignments (CA). Each computer assignment is similar to a mini project and will practice the concepts learned in the course. You will need to type your computer assignment in a document and upload your assignment to Canvas as a pdf.

The computer assignment is due by 11:59pm on the date given on the course schedule. There will be a 5-point penalty per day the assignment is late. It will not be accepted after the second day beyond the due date.

Academic dishonesty on a computer assignment will result in a minimum penalty of a grade of zero on that assignment.

**Exams:** There will be four in-class exams during the semester. You will need to bring to the exam your student UFID#, picture ID, scientific calculator, and pencils/eraser. Smart devices, or any type of device that connects to the Internet or other people are not allowed.

In the case of conflict or illness, you must contact me at [s.stine@ufl.edu](mailto:s.stine@ufl.edu) prior to the exam – as soon as you realize you will be unable to take the exam at the scheduled time. As a pre-requisite for arranging a make-up exam, valid and detailed documentation is required. Each case will be reviewed individually. There are no retakes.
